WHEREAS, on April 19, 2007, Plaintiff requested a temporary restraining order and preliminary injunction based upon the verified Complaint and Motion for Temporary Restraining Order in this cause and the Affidavit of Mitch Steinberg, this Court finds there to be reasonable basis to believe that the

1 Plaintiff will suffer irreparable harm and damage as a result of the conduct of  
2 the Defendants.

3 This Court finds reasonable basis to believe that Defendants are not  
4 acting in accordance with the terms of the Buy-Sell Agreement entered  
5 between Plaintiff and Defendants on March 9, 2007, that Defendant West  
6 continues to reside in Plaintiff's property without authority and in violation of  
7 the Buy-Sell Agreement and Addendum thereto, and that Defendants are  
8 taking or are likely to take adverse actions to the interests of Plaintiff, thereby  
9 causing immediate and irreparable harm to it.

10 Based upon the foregoing, and based specifically upon the Court's  
11 observation that the interests of justice would be served and were intended to  
12 be served by (a) ordering the immediate eviction of Defendant West from the  
13 subject property at 38 Bayview Drive, Lakeside, Flathead County, Montana.

14 **IT IS HEREBY ORDERED** that Defendant West be and hereby is  
15 restrained from remaining in residence at the Plaintiff's property at 38 Bayview  
16 Drive, Lakeside, Flathead County, Montana.

17 This Restraining Order shall be effective until the date and time set  
18 herein for the hearing to show cause why this Order should not continue as a  
19 preliminary injunction. A copy of this Order, as well as a copy of the  
20 Complaint and Summons, shall be served upon Defendants as required by law.

21 Defendants are also ordered to appear before this Court on  
22 May 9th, 2007 at 8:30 o'clock A.m., then and there to show  
23 cause, if any they may have, why this Temporary Restraining Order should not  
24 continue as a preliminary injunction pending final determination of the merits  
25 of this cause.
