Plaintiff will suffer irreparable harm and damage as a result of the conduct of the Defendants.

This Court finds reasonable basis to believe that Defendants are not acting in accordance with the terms of the Buy-Sell Agreement entered between Plaintiff and Defendants on March 9, 2007, that Defendant West continues to reside in Plaintiff's property without authority and in violation of the Buy-Sell Agreement and Addendum thereto, and that Defendants are taking or are likely to take adverse actions to the interests of Plaintiff, thereby causing immediate and irreparable harm to it.

Based upon the foregoing, and based specifically upon the Court's observation that the interests of justice would be served and were intended to be served by (a) ordering the immediate eviction of Defendant West from the subject property at 38 Bayview Drive, Lakeside, Flathead County, Montana.
